In consideration of my appearance in the Production, and without further consideration, I acknowledge that the proceeds and results of my participation, including but not limited to still, video and audio recordings of my likeness, voice and/or interview (for the purposes of this Agreement, each is a "work", respectively) shall be the exclusive property of Producer in perpetuity and shall be considered a "work made in the course of employment" for Producer for the purposes of Canadian copyright law and a "work made for hire" for Producer for the purposes of U.S. copyright law. In and to the extent that any or all of the provisions of this Paragraph do not operate to vest fully and effectively in Producer all rights in and to the proceeds and results of my participation, I hereby transfer and assign to Producer all rights, titles and interests of whatever kind and character whatsoever, including copyright in perpetuity and all ancillary rights throughout the universe (including sequel, prequel and spinoff productions and all so-called lending and rental rights), in any and all languages, in any and all media (now known or hereafter devised), including but not limited to film, television, print, digital and any online social media, in and to the results and proceeds of my participation in the Production including all rights of production, synchronization, performance, manufacture, exploitation, recordation and reproduction by any method or device. I further agree that the Producer or any persons designated by Producer shall be entitled without any further consent to use and authorize the use of my name, likeness, biography, photographs and recordings from the Production in advertising and promoting the Production as well as Producer in any and all media. I agree that my participation in the Production may be edited, added to or deleted at the Producer's sole discretion and I hereby unconditionally and irrevocably waive the benefit of any provision of law known as "moral rights" prevailing now or in the future in any part of the world, to the extent it may be waived. I understand and agree that there will be no payment due in connection with my participation in the Production.

I expressly release Producer and its affiliates, members, directors, officers, agents, successors, licensees and assigns from and against any and all claims, demands, or causes of action which I (or my heirs, dependents, assigns, agents and/or representatives) have or may have for invasion of privacy, defamation, infringement of copyright or any other cause of action arising out of production, distribution, broadcast or exhibition of the Production or the uses permitted herein, including, without limitation, arising out of any act or omission of any released party or other participants. In no event shall I have the right to obtain or enforce any injunctive, equitable, or other relief which would in any manner prevent, delay or interfere with the complete exercise by Producer of the rights granted herein.

The Producer may transfer and assign this Agreement or all or any of its rights or privileges hereunder to any entity or individual without restriction. This Agreement shall be binding on all of my successors-in-interest and heirs. This Agreement sets forth the entire agreement between the Producer and I with respect to the subject matter hereof and may not be altered or amended except in writing signed by both parties.

I have read and fully understand all of the terms of this release. This release shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein and I expressly attorn to the exclusive jurisdiction thereof.
